



Message from National Co-Convenors

National Co-Convenors

Over the past 12 months, the Federal political environment and national skills and education policy landscape has been shaped by the transformative change agenda ushered in by the Albanese Labor Government from mid 2022. This agenda has resulted in attention on education, training, employment and the centrality of skills agendas for Australia's future prosperity. These are the core areas of WAVE's remit - along with interrelated matters that impact gender equality in other portfolios such as welfare and migration. This has led to a year of vigilance and fast paced advocacy for WAVE.

As an organization, WAVE has remained steadfast in its commitment to enhancing the prominence of women in the workforce and education, focusing on rectifying inequities within the skills and labor market. Central to this mission is the recognition and prioritization of the lived experiences of those most disadvantaged in our education and training system, particularly women and girls. This involves acknowledging individual talents and providing unwavering support for their career growth while respecting their personal circumstances.

Despite our relatively small size, WAVE takes great pride in forging productive relationships with the Federal government. Key highlights from 2023 include:

- 1. Early congratulations extended to Professor Peter Dawkins AO on his appointment as Acting Commissioner for Jobs and Skills Australia (JSA). We promptly engaged with the Interim Commissioner and the JSA team to discuss gender equality and offered our services to promote gender equality in the formulation of JSA principles and the identification of goals for this new agency.
- 2. Participation in the skills and training pre-Budget locked-up session for the first time, alongside other key stakeholders. We have remained actively involved in federal policy discussions concerning equity and equality in skills policy during this period of reform.
- 3. Active participation in the recent JSA Symposium in Canberra, as well as attendance at the National Press Club Address delivered by Professor Dawkins.

Public engagement

Forums and Events

Transforming Education and Training in Australia 15 February 2023

A policy forum that welcomed delegates from Victoria, Australia and from overseas, was held to identify challenges, and opportunities was held in partnership with, the Australian Coalition for Education Development (ACED), Adult Learning Australia (ALA) and RMIT Jean Monnet Centre of Excellence. The forum which was delivered online and in person, contributed to the current policy conversations on transforming education and training in Australia from the perspective of ensuring that principles of equity, gender, and sustainability are embedded in employment, education and skills development.

Roundtable - Australian Apprenticeship Service and Supports 8th December 2022

WAVE coordinated a round table of its members to facilitate feedback on the Department of Employment and Workplace Relationship Discussion Paper on Australian Apprenticeship Services and Supports. This round table resulted in the creation of a submission for the Australian Government

Presentations

Public Hearing - Inquiry into the Perceptions and Status of Vocational Education and Training - 27 July 2023

WAVE coordinated a presentation to the House Standing Committee on Employment Education and Training to centre the lived experience of students and educators in Australia's VET system. The presentation enabled the Committee to hear some of the real experience of end users of the VET sector, and how inequtity and inequitable systems drive perceptions.

AVETRA 2023 Conference - Pre-conference workshop 26 April 2023

WAVE presented a workshop on inequity in Vocational Education and Training. Entitled "Making a transformational difference: Steps to address inequity in VET" the session talked participants through the evidence of inequity and the process to address it.

Equity Rights Alliance (ERA)

WAVE is a member of the Equality Rights Alliance, one of the National Women's Alliances. Dr Jan Edwards represented WAVE at the Annual Members meeting in Melbourne. A number of changes were made to the organisations operating procedures at the meeting.

ERA is a program of YWCA Australia and consists of a Staff Secretariat (Secretariat) and the ERA Advocacy, Policy and Advisory Council (ERAAPAC). YWCA Australia receives funding from the Commonwealth Government under a grant agreement to conduct the ERA program (Funding Contract). YWCA Australia is responsible for the delivery of the ERA Program under the Funding Contract and makes all operational and other decisions in relation to the ERA Program and the activities of ERA.

ERA APAC's role is to provide any recommendations that may be requested by YWCA Australia from time to time in relation to matters covered by the ERA APAC Terms of Reference (see below). All recommendations made by the ERA APAC are non-binding and any decision made by YWCA in relation to any matter the subject of a recommendation by the ERA APAC is final and conclusive and YWCA AUSTRALIA has absolute discretion to reject or decide not to pursue any such recommendation.

WAVE is a member of the ERA Advocacy, Policy and Advisory Council (ERAAPAC) and executive team members participate in a number of work groups (Membership; Housing Policy; Economic Security Policy; Data Policy (including time use survey campaigning); Climate Policy; International Group).

Global Campaign for Education World Assembly

Dr Jan Edwards represented Asia South Pacific Association for Basic and Adult Education (ASPBE) at the meeting held in South Africa in November 2023.

The Global Campaign for Education (GCE) held its 7th World Assembly on November 22–24, 2022, in Johannesburg, South Africa. The 7th GCE World Assembly convened over 200 delegates from over 130 countries, comprising representatives from grassroots organisations, teachers' unions, children's and youth rights organisations, NGOs, parent associations, youth and student groups, and community groups.

Action emerging from the 7th GCE World Assembly includes renewed GCE governance structures and a collective commitment to overcome exclusion, discrimination, and the impoverishment of education around the world, including strengthening youth and student involvement. Outcomes and recommendations were highlighted in the 7th GCE World Assembly political statement and press release

KEY ASSOCIATIONS

WAVE are proud members of the following organisations

Australian Coalition for Education and Development (ACED).

As a member of ACED, WAVE joins in partnership with other key organisations & people with a focus on adult education & training, adult learning and lifelong learning both in Australia as well as through regional and global networks and actors. This collaboration strengthens advocacy here & wider for our colleagues, given Australia's acceptance of related global agreements through the UN & like bodies.

Through ACED, WAVE was a signatory endorsing the submission developed collaboratively with Adult Learning Australia (ALA), RMIT, ASPBAE & PASCAL & PIMA (Promoting, integrating & Mobilising Adult Learning & Education) to the Australian Government's White Paper on Employment in November 2022.

In 2023, we participated in informal intergovernmental consultations held for CSOs to gather input for UN's Summit of the Future that took place in February 2023.



WAVE INTERNATIONALLY

WAVE is one of a relatively small number of specialist women's NGOs/CSOs that focuses on adult education & training for women, & its links to decent work. WAVE members have contributed to gender equality advocacy (especially around education & training & access to decent work) to a number of key international events in the last year, mostly through participation in online consultations and associated events. The ongoing focus on the UN's Sustainable Development Goals (SDGs) is central to this, as is CSW (Commission on the Status of Women).

This work is important in a number of ways: to stand in solidarity with relevant women's organisations globally including those who work to insert voice from 'the south; to ensure gender equality remains active on international agendas; to ensure attention is directed to post school education and training and adult community education & learning.

WAVE's network is extended through our selective participation in regional & global activities, through Women's Major Group (WMG), NGO CSW, ASPBAE (who consult prior to and have direct input at the key global events), APCREM as detailed in previous annual reports. We are also linked through ERA & ACED.

2022- 2023 has been a busy period, including the run up to & the SDG Summit held in September 2023 in New York for the mid-point review of the 2030 Agenda for Sustainable Development and the implementation of its 17 Sustainable Development Goals (SDGs). The Summit adopted a political declaration that will provide a road map for putting the world back on track to achieve the SDGs by their 2030 deadline. CSW 67's priority theme for 2023 was 'Innovation and technological change, and education in the digital age for achieving gender equality and the empowerment of all women and girls' while reviewing progress on Challenges and opportunities in achieving gender equality and the empowerment of rural women and girls (CSW 62). WAVEs input was through WMG, NGO CSW & ERA.

Jane Anderson attended WMG's online Regional Forum for Sustainable Development for Gender Equality in November 2022 as WAVE's representative. The Forum was joined by influential speakers from the United Nations, UN Regional Commissions, and civil society to raise awareness on the importance of feminist advocacy at the regional UN sustainable development processes and included concrete suggestions and recommendations towards advocacy at these spaces for gender equality and women's human rights. Jane also presented a session on the SDGs and TVET at the World Federation of Colleges and Polytechnics annual conference in Montreal, Canada in April 2023.

Through WAVE's membership of ASPBAE, L'Amour Gina Whewell was offered a participants place in the Global Coalition for Gender Transformative Education (Feminist School) conducted for CSO members in September 2022 by United Nations Girls Education Initiative (UNGEI).

WAVE also participated in forums held by ASPBAE as well as the Clean Energy Ministerial Empowering People Initiative online workshops to connect educators and industry through a solutions-based focus on 'Integrated Policymaking & Empowering Communications: Clean Energy Workforce & Economy'.





Financial Overview

Women in Adult and Vocational Education (WAVE) is an incorporated association registered in Victoria under the Incorporated Associations Act. WAVE was registered as an Incorporated Association on the 20 March 1991 and is classified as a teir 1 organisation with our own rules of Association.

WAVE is not registered for GST.

Material Matters for this Annual Report

The change of National Co-coordinators, Public Officer and Treasurer after 2022 AGM necessitated a handover period of documentation and subsequent updating of official records. This has been accompanied by an updating of financial arrangements and processes.

From 11 November 2022 to 30 October 2023 WAVE had a small number of transactions on the bank accounts.

Income

\$984.65 was generated in income from membership, donations, sponsorship and interest on the business online saver account. WAVE did not undertake any other business.

Expenses

Expenses totalled \$4,219.48 with the main expenses for insurance (\$1462.26) and the issuance of the Sue Salthouse Award (\$1000) resulting in a deficit of \$3234.83.

Assets & Liabilities

The balance sheet for WAVE consists of two bank accounts and a PayPal wallet totalling \$29,385.75. This represents a reduction of approximately 8 per cent in total assets from the 2021-22 to 2022-23 period. There are no current liabilities or outstanding creditors.

2023-24 budget planning

Recurring expenses under review are the insurance costs and the Sue Salthouse Award criteria and amount. A subcommittee to appraise membership recruitment will be convened.
